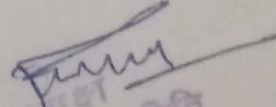

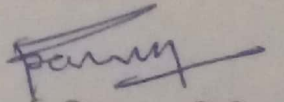

CONSULTING AGREEMENT

This agreement of employment is made on this 1 July 2014 between **Arminus Software PVT. LTD.** hereinafter referred as the **Company** contracted by PricewaterhouseCoopers Private Limited ("PwC") hereinafter referred to as **Client**

Mr. Satyaveer Mishra, Son of Mr. Santosh Mishra, hereinafter referred to as the **Consultant** for supporting roll out of MIS in Madhya Pradesh. The duty station will be duly communicated by the Client.

IN CONSIDERATION of the foregoing and of the mutual covenants set forth below, the parties, intending to be legally bound, agree as follows:

1. Retention as Consultant. The Company hereby retains Consultant, and Consultant hereby agrees to render consulting services to the Company and Client, upon the terms and conditions set forth herein.
2. Duties. Consultant covenants and agrees that, as an independent Consultant, he will perform all services requested of him by the Company and the Client, acting through his own. The Consultant will not get engaged in any other assignment and/or with any other organization.
3. Independent Consultant Status. The parties recognize that Consultant is an independent entity and not an employee, agent, co-venturer, or representative of the Company and that the Company will not incur any liability as the result of Consultant's actions. Consultant shall at all times disclose that he is an independent Consultant of the Company and shall not represent to any third party that he is an employee, agent, co-venturer, or representative of the Company other than as expressly authorized by the Company. Consultant shall not be entitled to receive any employment benefits offered to employees of the Company, including but not limited to: workers' compensation coverage; savings or profit sharing plans; stock option, incentive or other bonus plans; health, dental or life insurance coverage; and paid vacations. The Company shall not exercise any control except as enumerated over the Consultant.
4. Compensation. The consultant will raise proper invoice for the services in the Company for process development, client management of the company. The Invoice shall contain the PAN numbers, Service Tax registration numbers (if applicable), address of communication, telephone numbers etc. The Company shall pay to Consultant, as compensation for the services to be rendered, the sum of **INR 33,000 per month**. The payment of such consultancy will be paid based on the approved timesheet (timesheet format at Appendix A) from the client. Company will deduct TDS of 10% (as per the Government applicable rate) on the service bill raised by the Consultant.

For work related travel to the aforementioned districts and to state head quarter, the boarding and lodging arrangements will be made by the Consultant as per permissible per diem ceiling which has been fixed at Rs. 1500/- . Other expenses such as travel will be reimbursed subject to monthly ceilings as approved by the Client. All expenses will be reimbursable on submission of original bills, tickets and receipts. Communication costs will be reimbursed subject to a monthly ceiling of Rs 1500. All expense reimbursements shall be submitted as supplementary bill to fee invoices being submitted.
