APPOINTMENT LETTER

Dear Mr. Rahul Kumar,

2. Your gross salary is Rs.35,000 p.m.+ Accommodation including all expenses, with an anticipated start date when you will receive the appointment letter on the same day you join. Please note that this letter is valid until 05/01/2025.
3. The notice period for termination 30 days/ resignation will be Two month from either side.
4. That you will be on probation for a period of six months. The period of probation can be extended at the discretion of the management and you will continue to be a probation till an order of confirmation has been issued in writing.
5. Your future increments or promotion or any other salary increase shall be based on merit considering your periodic and consistent overall performance, business conditions and other parameters fixed from time to time at the discretion of the management and shall not be considered merely as a matter of right.
6. During the period of service with the company, you shall not indulge and/ or take part in any activity of formation of council and / or association or become a member being part of management staff which are found to be detrimental in the interest of the company in any way. You thereupon, may be governed by service conditions and other terms of the said concern as may be applicable. The employer does not have to pay the employee anything if the employee failed (Absconded) to report for duty without permission or justification Or during your probation period in case of your short notice registration we will not be accepted for which the management will not be answerable.
**During the probationary period, there will be no entitlement of any kind of leave, be it Casual Leave, Sick / Medical Leave, Academic Leave etc. or any other kind of leave for any employee(s). Therefore, any other leave if availed will be treated as without pay (LWP).

9. Your services are liable to be terminated at any time:
 - i) During probation or after confirmation, in case you are found to be medically unfit.
 - ii) As and when the Company comes to know of any conviction by the Court of Law during the tenure of your service with us or conviction and / or any bad record in the past under the previous employer, or because of your giving false information at the time of your appointment or concealed any material information or given any false details in the application form or otherwise as regard age, education qualification, experience, salary etc.

11. All documents, plans, drawings, prints, trade secrets, technical information, reports, statements, correspondence etc., written or unwritten and also information and instructions that pass through you or come to your knowledge shall be treated as confidential. You shall not utilize them for your own use or disclose to other persons during or after your employment. During the course of employment with the Company, you will acquire, gain, generate, gather and develop knowledge of and be given access to business information about products activities, know – how, methods or refinements and business plans and business secrets and other information concerning the products / business of the Company, hereinafter called the “SECRETS”.
