You will be responsible for implementation of Climate Smart Village programme in Chhindwara district in coordination with Zilla Panchayat, RGM and concerned government departments, ITC Ltd. and local beneficiaries, organize field demonstration, facilitate convergence of govt. schemes for beneficiaries and conduct training programmes for Govt. officers and farmers.

The terms and conditions of the appointment are as follows:

- 1. The appointment will be effective from the date of your joining to the post until 31st March 2025.
- 2. The post is temporary with option for extension beyond March 2025 subject to your satisfactory performance.
- 3. You will be posted in Chhindwara.
