




Subject: Appointment of Agriculturist under the project "Promotion of Climate Smart Practices In villages of 21 selected districts of Madhya Pradesh".

On the basis of online personal interview with you on 22nd June 2024, we would like to offer you the post of Agriculturist under the project "Promotion of Climate Smart Practices In villages of 21 selected districts of Madhya Pradesh". You will be responsible for implementation of Climate Smart Village programme in Chhindwara district in coordination with Zilla Panchayat, RGM and concerned government departments, ITC Ltd. and local beneficiaries, organize field demonstration, facilitate convergence of govt. schemes for beneficiaries and conduct training programmes for Govt. officers and farmers.

The terms and conditions of the appointment are as follows:

1. The appointment will be effective from the date of your joining to the post until 31st March 2025.
2. The post is temporary with option for extension beyond March 2025 subject to your satisfactory performance.
3. You will be posted in Chhindwara.
4. The post carries a consolidated pay of Rs. 35,000/- (Rupees Thirty five thousand only) per month, which is inclusive of all allowances, premium for personal health insurance etc.
5. Actual motor cycle mileage upto Rs. 4,500/- per month will also be payable to you for field travel.
6. You will be entitled to TA & DA as per actual expenses and NCHSE Rules for outstation travels.
