Offer Letter: Assistant Manager

Dear Prabhat Shukla,

4. This is a provisional offer. Your appointment and issuance of the final Letter of Appointment is subject to the following conditions:

- i. Background Verification
- ii. Medical fitness (Medical declaration enclosed as Annexure II)
- Production of original documents and certificates regarding educational qualifications, identity proof and employment details (if any) as detailed in the employment application form.

5. Joining in the company is subject to generation of employee code. Mere submitting the Joining Kit does not entitle the status of employee of the company. On receiving the joining kit the documents are validated post which the decision of hiring with the company is taken. The candidate will be deemed to have not joined the company unless his/her employee code is generated and communicated by the company.

6. Candidates who have earlier worked with SBI Life will be considered as an instance of rehiring. In such cases where you possess insurance agency code of another insurance company(ies), you are required to ensure that your code is deactivated and you submit the NOC from the concerned insurance company(ies) within 60 days of your joining SBI Life failing which SBI Life reserves the right to keep your salary on hold and take such action as deemed necessary which may also include termination of your services from SBI Life.

9. The company forbids hiring or holding employment of insurance agents whose agency code has been blacklisted. You are hereby advised to make sure the same before acceptance of this offer or else it will be considered as a violation of code of conduct and your continuation in the company will be solely at its discretion.
